### JOURNAL OF THE SENATE

Monday, September 30, 2024.

Met at nine minutes past eleven o'clock A.M. (Mr. Collins in the Chair) (having been appointed, by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

The Chair (Mr. Collins), members, guests and staff then recited the pledge of allegiance to the flag.

#### Matters Taken Out of the Orders of the Day.

There being no objection, the following matters were taken out of the Orders of the Day and considered as follows:

The Senate Bill amending chapter 305 of the acts of 2016 relative to the year-round market rate rental housing trust fund in the town of Provincetown (Senate, No. 2744),-- was read a third time.

Pending the question on passing the bill to be engrossed, Mr. Cyr presented an amendment substituting a new draft entitled "An Act further regulating the Year-round Market Rate Rental Housing Trust Fund in the town of Provincetown" (Senate, No. 2951).

The House Bill authorizing the town of Natick to continue the employment of police officer John Haswell (House, No. 4686),-- was read a second time, ordered to a third reading, read a third time and passed to be engrossed, in concurrence.

Ms. Stanley was the owner of Vibrant Event Productions, a longtime business owner of Karen's Boutique in South Boston, Whispers Boutique's throughout New England and longtime manager of Kay Clothes Inn in South Boston.
