Adjournment in Memory of Kevin Riley.

The Senator from Essex and Middlesex, Mr. Tarr, moved that when the Senate adjourns today, it does so in memory of Mr. Kevin Riley of Newburyport.

Mr. Riley passed away on August 4, 2024, of pancreatic cancer. Mr. Riley owned and operated Partridge in a Bear Tree in Market Square Newburyport for 23 years. His store is an iconic presence in downtown, drawing in shoppers from the North Shore and beyond. Originally started as a Christmas themed store, Kevin grew the business to include decorations and gifts for a variety of holidays. As the business grew, he added a second store on Salem's Pickering wharf 10 years ago.

Kevin knew that it was important to support local craftsmen and made it a point to carry products produced by a number of local manufacturers. He was a passionate supporter of his fellow merchants and understood that their collective success played a significant role in making Newburyport such a special community.

Kevin was particularly proud of seeing familiar faces return each year with many families using his well decorated store as a backdrop for their holiday photo.

After being diagnosed with pancreatic cancer in February 2023, Kevin formed a team

to support PanCan, a group that raises money for pancreatic cancer research and helps families with treatment. With the support of family, friends and the business community, he raised \$46,795, making him the second top fundraiser out of 182 teams. Kevin tragically lost his battle with pancreatic cancer on August 4, 2024.

When he wasn't busy at his stores, Kevin spent time both instructing and participating in color guard. He was an instructor at several high schools in Massachusetts and New Hampshire. One former student recalled that he had a way of instilling confidence and rooting for the underdog. For the past several years he performed with the New England Pride Color Guard, a group that performed at Pride events around the region.

Kevin is survived by his husband Ronald Senter, his partner for the past 18 years. His stores and joyful presence will continue as a vibrant part of the community through the work of his husband, other family members and the support of friends and his fellow small business owners.

Accordingly, as a mark of respect to the memory of Kevin Riley, at twenty minutes past eleven o'clock A.M., on motion of Mr. Tarr, the Senate adjourned to meet again on Monday next at eleven o'clock A.M.
