JOURNAL OF THE SENATE

Thursday, November 7, 2024.

Met at eleven minutes past eleven o'clock A.M. (Mr. Rush in the Chair) (having been appointed, by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

The Chair (Mr. Rush), members, guests and staff then recited the pledge of allegiance to the flag.

Distinguished Guests.

There being no objection, the following guests were introduced:

The Chair (Mr. Rush) introduced, on the Rostrum, Congressman Stephen Lynch of South Boston. Congressman Lynch was sworn in as a member of the United States House of Representatives on October 16, 2001. He is currently a member of the Financial Services Committee, where he serves as Ranking Member of the Subcommittee on Digital Assets, Financial Technology and Inclusion and is a member of the Subcommittee on Capital Markets. Congressman Lynch also serves as the lead Democrat to the Financial Services Committee's bipartisan Working Group on Artificial Intelligence. Prior to being elected to the United States House of Representatives, he was the State Representative from the 4th Suffolk District from 1995-1996 and then became the State Senator from the 1st Suffolk District from 1996 to 2001. Congressman Lynch was also recognized for his work with the Ironworkers Union, becoming the youngest president in the history of the union at the age of 30. The Senate welcomed him with applause, he addressed the Senate from the Rostrum, signed the guestbook and withdrew from the Chamber.

The Chair (Messrs. Rush and Timilty) introduced, in the rear of the Chamber, Representative John Rogers of Norwood and former Representative Jim Brett. They were visiting the Senate Chamber in recognition of the adjournment remarks in honor of Lucille Brett. The Senate welcomed them with applause and they withdrew from the Chamber.
