JOURNAL OF THE SENATE

Monday, August 4, 2025.

Met at two minutes past eleven o'clock A.M. (Ms. Miranda in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

The Chair (Ms. Miranda), members, guests and staff then recited the pledge of allegiance to the flag.

PAPERS FROM THE HOUSE.

A Bill authorizing the commissioner of capital asset management and maintenance to grant certain easements to the town of Bourne (House, No. 4364,-- on House, No. 3435) [Local approval received on House, No. 3435],-- was read.

Bourne,-- land.

There being no objection, the rules were suspended, on motion of Mrs. Dooner, and the bill was read a second time and ordered to a third reading.

A petition (accompanied by bill, House, No. 4374) of Steven George Xiarhos that a certain overpass on State Route 6 in the town of Sandwich be designated as the U.S. Marine Staff Sergeant Raymond G. Tourville veterans memorial overpass,-- was referred, in concurrence, under suspension of Joint Rule 12, to the committee on Transportation.

The engrossed Bill authorizing the Massachusetts Water Resources Authority to supply water to the Lynnfield Center Water District within the town of Lynnfield (see House, No. 972),-- came from the House with the endorsement that the House had amended the bill by inserting before the enacting clause the following emergency preamble:

Lynnfield Center Water District.

"Whereas, The deferred operation of this act would tend to defeat its purpose, which is to forthwith supply water to the Lynnfield Center Water District, therefore it is hereby declared to be an emergency law, necessary for the immediate preservation of the public convenience."

The rules were suspended, on motion of Mrs. Dooner, and the House amendment was considered forthwith and adopted, in concurrence.

Emergency Preamble Adopted; Engrossed Bill Enacted.

An engrossed Bill authorizing the Massachusetts Water Resources Authority to supply water to the Lynnfield Center Water District within the town of Lynnfield (see House, No. 972, amended), having been certified by the Senate Clerk to be rightly and truly prepared for final passage and containing an emergency preamble,-- was laid before the Senate; and, a separate vote being taken in accordance with the requirements of Article LXVII of the Amendments to the Constitution, the preamble was adopted, in concurrence, by a vote of 2 to 0.

Id.

The bill was signed by the Acting President, (Ms. Miranda) and sent to the House for enactment.

Subsequently, the bill, which originated in the House, came from the House with the endorsement that it had been enacted in that branch.

The Senate then passed the bill to be enacted; and it was signed by the Acting President (Ms. Miranda) and laid before the Governor for her approbation.

Order Adopted.

On motion of Mrs. Dooner,--
