Thursday, September 18, 2025.

Met at seven minutes past eleven o'clock A.M. (Mr. Brownsberger in the Chair) (having been appointed, by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

The Chair (Mr. Brownsberger), members, guests and staff then recited the pledge of allegiance to the flag.

There being no objection, the Chair (Mr. Brownsberger) handed the gavel to Ms. Miranda for the purpose of an introduction. Legacy, at age 7, was named an All-American and placed 5th in the 800-meter run and 7th in the 400-meter at the USATF Junior Olympic Games in the 8-and-under category. Trinity, at age 10, was also named an All-American and earned 6th place in the 800-meters in her age group and then went on to finish 2nd in the Junior Olympic Games, shortly after competing in Savannah, Georgia. Legacy and Trinity were accompanied by their coach, Tomorrow Peoples, and various family members. The Senate applauded their accomplishments and they withdrew from the Chamber.

State primary election date.

There being no objection, the rules were suspended, on motion of Mr. Fernandes, and the bill was read a second time.

Pending the question on ordering the bill to a third reading, Ms. Rausch presented an amendment by inserting the following section:-

"SECTION X. Chapter 53 of the General Laws, as appearing in the 2022 Official Edition, is hereby amended by striking out section 28 and inserting in place thereof the following section:-

Section 28. (a) (1) State primaries shall be held on the second Tuesday in June in evennumbered years and on the fourth Tuesday preceding special state elections, except that primaries before special elections for senator or representative in congress shall be held on the sixth Tuesday preceding said elections.

- (2) If a religious holiday falls on or immediately before the second Tuesday in June in an even-numbered year, the state primary shall be held on a date set by the state secretary within 7 days of the second Tuesday in June.
- (b) The state secretary shall publish the date of the state primary not later than February 1 of each even-numbered year by: (1) providing notice of the date to the state parties; (2) filing notice with the state publications and regulations division; (3) posting the information on the website of the state secretary; and (4) any other means necessary to ensure proper notification.
- (c) (1) Presidential primaries shall be held on the first Tuesday in March in any year in which presidential electors are to be elected.
- (2) Notwithstanding any provision of law to the contrary, any town may hold its preliminary or regular town elections on the same date designated as the date to hold a presidential primary, in any year in which presidential electors are to be elected, provided that such election is by a ballot independent of the ballot used at a presidential primary. City and town primaries before all city and town elections shall be held on the twenty-eighth day preceding such elections.
- (d) Except in Boston, primaries shall be held wholly or partly by wards, precincts or towns, as the city or town executive body may designate.
- (e) Notwithstanding the provisions of any general or special law, town charter or bylaw to the contrary, if the date for holding a preliminary, primary, or town election or annual town meeting falls within thirty days before or after the presidential primary, the town executive body, after consulting the town clerk may, by majority vote, establish a date between February first and May thirty-first for holding such preliminary, primary or town election or annual town meeting. Any preliminary, primary or town election or annual meeting shall be held on the date or dates established and shall be called as provided by sections 9A and 10 of chapter 39.
- (f) Notwithstanding the provisions of any general or special law to the contrary, if the date for holding a district election falls within 30 days before or after the presidential primary, the prudential committee, if any, otherwise the commissioners, of the district may, by majority vote, establish a date between February 1 and May 31 for holding such district election. Any district election shall be held on the date established and shall be called as provided by section 119 of chapter 41. For the purposes of this section, district shall mean a district created by special law or established under the provisions of a general law."

The amendment was rejected.

uplifting spirit that drew people to him. He was brilliant, quick-witted, and deeply loving and loved back as a father of 6, a brother, a son, and a friend. He took great pride in being a present and supportive father, working two and sometimes three jobs to provide for his children. He was dedicated, resilient, and determined to change the narrative of his life. As a teen he was a dancer and entertainer and quite popular.

Born and raised in Dorchester and Randolph, Ricardo's journey was not without hardship.

After a joyride in Dorchester when he was 17, he didn't receive a second chance.

For decades, he cycled in and out of incarceration, facing an unjust system that took years of his life. Yet he never stopped fighting. He wrote his own legal motions, earned the respect of judges, and eventually won his freedom in September of 2021. When he came home, he poured his energy into rebuilding. He became a full-time dad, reconnected with his family, and gave back to his community. He worked two jobs, seven days a week. His dedication was recognized when Fathers' UpLift named him Father of the Year 2025, a reflection not only of his actions, but of his heart.

Even with all he accomplished, Ricardo carried pain that was often invisible to others. Despite our love, our support, and our resources, the weight became too heavy, and on August 8th, he passed away after a long and difficult struggle with mental health. Three days after he harmed himself.

September is Suicide Prevention Awareness Month, and Ricardo's passing is a heartbreaking reminder that mental health challenges are real — and that reaching out to our loved ones can make a difference, sometimes even save a life. It also reminds us the Mental Health services should be improved in carceral settings, at local community health centers and the system of Reentry that we invest millions into must be improved to meet the complex needs.

If you or someone you love is struggling, please know that help is available. In Massachusetts, you can dial 2-1-1 for local resources or 988 — the National Suicide and Crisis Lifeline — to speak with trained counselors 24 hours a day.

Ricardo's story is one of resilience, love, and possibility — and while my heart is broken, I will forever be proud to call him my brother. I miss his laughs, hugs and daily text messages.

I respectfully ask that when the Senate adjourns today, it do so in memory of Ricardo Barbosa, and that we honor his life by being gentler with one another, by checking in on the people we love, and by remembering that none of us are the sum of our worst days and mistakes. We all should feel seen, heard, supported and given the grace we desire to redeem ourselves. I love you and wish we had more time.

Accordingly, as a mark of respect to the memory of Ricardo Miguel Zeferino Barbosa, at twenty-four minutes past one o'clock P.M., on motion of Mr. Tarr, the Senate adjourned to meet again on Monday next at eleven o'clock A.M.
