Kennedy as senator from the First Middlesex district, the office of senator from the First Middlesex district is vacant. By the authority of article XXIV of the Amendments to the Constitution, the Senate directs the president of the Senate to issue a precept setting forth March 3, 2026, as the day for holding an election to fill the vacancy in the First Middlesex district, consisting of the city of Lowell and the towns of Dracut, Dunstable, Pepperell and Tyngsborough in the county of Middlesex.

to authorize the Massachusetts Water Resources Authority to supply sewer services to certain parcels of land in the town of Sharon, therefore it is hereby declared to be an emergency law, necessary for the immediate preservation of the public convenience."

There being no objection, the rules were suspended, on motion of Mr. Fattman, and the bill was read a second time and was amended, as recommended by the committee on Rules.

The bill, as amended, was then ordered to a third reading, read a third time and passed to be engrossed, in concurrence with the amendment.

Ms. Lovely, for the committee on Rules, reported that the following matter be placed in the Orders of the Day for the next session with an amendment.

The House Bill authorizing the Massachusetts Water Resources Authority to provide sewer services to a certain parcel of land in the town of Sharon (House, No. 4009, amended) (the committee on Rules recommending that the bill be amended by inserting before the enacting clause the following emergency preamble:-

"Whereas, The deferred operation of this act would tend to defeat its purpose, which is to authorize the Massachusetts Water Resources Authority to supply sewer services to certain parcels of land in the town of Sharon, therefore it is hereby declared to be an emergency law, necessary for the immediate preservation of the public convenience."

Ordered, That notwithstanding Senate Rule 7 or any other rule to the contrary, the House Bill making appropriations for the fiscal year 2025 to provide for supplementing certain existing appropriations and for certain other activities and projects (House, No. 4615) to be reported by the committee on Ways and Means with a recommended new text Senate document numbered 2655 on Monday, October 20, 2025, and read into the Senate Journal on Monday, October 20, 2025, shall be placed in the Orders of the Day for a second reading on Thursday, October 23, 2025, for immediate consideration with the Ways and Means new text pending.

All amendments shall be filed electronically in the office of the Clerk of the Senate by 5:00 P.M, on Tuesday, October 21, 2025. All such amendments shall be second reading-amendments to the Senate Ways and Means new text (Senate, No. 2655), but further amendments in the third degree to such amendments shall be in order. The Clerk shall further specify the procedure and format for filing all amendments, consistent with this order.

After the bill, as amended, is ordered to a third reading, it shall immediately be read a third time and the question shall then immediately be on passing it to be engrossed, and no amendments shall be in order at the third reading of the bill unless recommended by the committee on Bills in the Third Reading.

The rules were suspended, on motion of Mr. Fattman, and the order was considered forthwith and adopted.

The bill will be placed in the Orders of the Day for Thursday, October 23, 2025, for a second reading with the amendment pending.

Report of a Committee.

By Mr. Rodrigues, for the committee on Ways and Means, that the House Bill making appropriations for the fiscal year 2025 to provide for supplementing certain existing appropriations and for certain other activities and projects (House, No. 4615),-- ought to pass, with an amendment striking out all after the enacting clause and inserting in place thereof the text of Senate document numbered 2655 [Direct Appropriations: \$2,302,196,732.00 -- This legislation makes \$2,302,196,732 in direct fiscal year 2025 appropriations, with a net cost to the Commonwealth of \$795,714,639 after federal financial participation.]

Born and raised in Worcester, Mary graduated from Notre Dame Academy and Worcester State College. After raising her four children, she returned to teaching and became a cherished member of the Burgess Elementary School staff. Her enthusiasm and warmth left a lasting impression on students and colleagues alike.

She served six terms on the Sturbridge Board of Selectmen over 17 years, many of those as Chair, where her leadership was marked by energy, integrity, and a signature sense of humor. Her commitment to public service also included time on the Zoning Board of Appeals and the Open Space Committee.

Mary's life was centered around her family and friends. She cherished time spent with her husband of 57 years, Charles, her children Brian, Michael, Kerry, and James, and her grandchildren Emily and Liam. She found joy in summers by the pool, vacations on Cape Cod, and trips to Ireland. Her courage during a nineteen-year battle with a rare autoimmune disease was a testament to her strength and spirit.

She was predeceased by her son James and her brothers Charles, Matthew, and Richard O'Connor. Her legacy of love, service, and laughter will live on in all who knew her.
