The Senate Bill amending certain laws relative to individuals with disabilities (Senate, No. 2563),-- came from the House passed to be engrossed, in concurrence *with an amendment*, striking out all after the enacting clause and inserting in place thereof the text contained in House document numbered 4704; and by striking out the title and inserting in place thereof the following title: "An Act relative to individuals with intellectual or developmental disabilities".

"Whereas, the deferred operation of this act would tend to defeat its purpose, which is to defeat its purpose, which is forthwith to make corrective changes in certain general laws relative to persons with disabilities, therefore it is hereby declared to be an emergency law, necessary for the immediate preservation of the public convenience."

The motion was accepted; and the further amendments were adopted.
