## Adjournment in Memory of Francis Xavier Bellotti.

The Senator from Norfolk and Plymouth, Mr. Keenan, joined by all members of the Massachusetts State Senate, move that when the Senate adjourns today, it does so in memory of Francis Xavier Bellotti.

Francis Xavier Bellotti passed away peacefully at the age of 101 in his home on December 17, 2024, with his family at his side.

Frank Bellotti was raised by his mother in Roxbury. He was just 14 when his father was killed in World War I.

In 1940, Frank graduated from Boston English High School and then served as a Navy Intelligence Officer during World War II in the Scouts and Raiders, a precursor to the U.S. Navy Seals. He was present on D-Day, June 6, 1944. He received the European-African Theatre Ribbon, Asiatic Pacific Ribbon (1 Star), a Presidential Unit Citation, and Victory Ribbon WWII.

Following his time in the military, Frank graduated from Tufts University and Boston College Law School, which propelled him to an illustrious career.

From 1963-1965 he served as Lieutenant Governor of Massachusetts.

In 1974, he was elected as the Massachusetts Attorney General and served three terms in this role. Where he fought for the expansion of civil rights and environmental protections. He was president of the National Association of Attorneys General from 1985-1985, was honored with the Louis C. Wyman award as the most outstanding attorney general in the United States, and later had an award named after him, presented to a member whose work furthered the mission of the Association.

After leaving office, Frank worked in private practice and helped found the Arbella Insurance Group in the 1980s. He also served as chairman of the Arbella Insurance Group.

In 2012, the Quincy District Court was renamed the Francis X. Bellotti courthouse in his honor, and in 2024 his hometown of Quincy honored him with a bronze plaque in Navy Park at Squantum Point in Quincy.

Frank and his beloved wife Maggie, to whom he was married for seventy-three years, lived and raised their twelve children in Quincy's Wollaston neighborhood before moving to Hingham several years ago. Maggie passed away in December 2022 at the age of 98.

Frank Bellotti is survived by 11 children, 25 grandchildren and 17 great-grandchildren.

By example, Frank encouraged and inspired countless people to enter public service, leaving a towering legacy of courageous leadership and moral guidance.

The Massachusetts State Senate offers its condolences to his loved ones.
