Thursday, May 1, 2025.

Met at nine minutes past eleven o'clock A.M. (Ms. Rausch in the Chair).

The Chair (Ms. Rausch), members, guests and staff then recited the pledge of allegiance to the flag.

There being no objection, the following guests were introduced:

The Chair (Mr. Collins) handed the gavel to Ms. Rausch for the purpose of an introduction. Ms. Rausch then introduced, in the rear of the Chamber, the Medfield High School girls varsity volleyball team, girls varsity basketball team and girls varsity hockey team. The three teams were recognized for winning the 2025 MIAA state championship titles for their respective sports. The Senate applauded their accomplishments and they withdrew from the Chamber.

The Chair (Mr. Collins) handed the gavel to Mr. Tarr for the purpose of an introduction. Mr. Tarr then introduced, in the rear of the Chamber, the Georgetown High School boys basketball team. The team was recognized for winning the 2025 MIAA Division 4 state championship title, the team's first championship title. Adjournment in Memory of Former State Representative, State Senator, Civic Leader and Mayor of Amesbury Nicholas J. Costello

The Senator from Second Essex and Middlesex, Mr. Finegold, the Senator from First Essex and Middlesex, Mr. Tarr, the Senator from Suffolk, Mr. Collins, the Senator from Bristol and Norfolk, Mr. Feeney, and the Senator from Bristol and Plymouth, Mr. Rodrigues, moved that when the Senate adjourns today it do so in memory and legacy of Nicholas J. Costello, the former State Representative, State Senator, civic leader and Mayor of Amesbury, who died peacefully at home, age 89 on March 17, 2025.

Born in Albany, New York, on August 22, 1935, he was the son of the late Nicholas Costello and Mary Clarke Costello. While enlisted in the U.S. Army, Nick was assigned to the U.S. Army Nike missile base in Nahant, Massachusetts. He met his wife Cynthia, in Lynn, where they started a family, moving to Amesbury in 1969.

Nick had an extensive record of public service -- as a school committee member and then town selectman. He was elected to the Massachusetts State Legislature from 1978-1991, first serving as State Representative and later as State Senator. From 1996 to 2001, Costello served as the City of Amesbury's first Mayor, successfully leading the transition from town government to city government. A major accomplishment of his tenure as mayor was to gain funding for redeveloping and renovating the downtown, including improving traffic flows.

A champion of environmental and social justice, Costello worked with local organizations for over 40 years to protect the natural beauty and quality of life for Merrimack Valley residents. As Senate Chairman of the Legislature's Committee on Energy, Senator Costello was a visionary helping to negotiate and regulate clean and renewable energy. He was selected to serve as the Massachusetts Senate liaison in discussions with Canada on the Hydro-Ouebec energy supply project.

Senator Costello also served as a member of the Commerce and Labor Committee, specializing in small business and labor issues. He was a member of the Natural Resources Committee and the Human Services and Elderly Affairs Committee. In 1988, he took on the chairmanship of the Special Senate Committee on Patient Care in State Mental Health Hospitals, and he notably authored women's health legislation requiring insurance companies to guarantee free mammograms and pap smears to patients.

After retiring as Mayor, Costello served as the Executive Director for Link House until 2014, continuing his life-long dedication to providing sober housing and transitional assistance to those in recovery. Additionally, he continued to serve as President of the Maudslay Arts Center in Newburyport, a role he began in 1993. While Senator, one of his proudest achievements was securing the former Maudslay Estate as park land, saving the

land as open space for residents to enjoy. He also served as a member of Amesbury's Economic Development Committee and Council of Aging.

Nick leaves behind a legacy of dedication and service and a lifetime of joyful memories with his wife Cynthia, of 64 years, and his five sons and five grandchildren.

Accordingly, as a mark of respect to the memory of Nicholas J. Costello, at sixteen minutes past twelve o'clock noon, on motion of Mr. Tarr, the Senate adjourned to meet again on Monday next at eleven o'clock A.M.
