JOURNAL OF THE SENATE

Thursday, May 29, 2025.

Met at twenty minutes past eleven o'clock A.M. (Mr. Collins in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

The Chair (Mr. Collins), members, guests and staff then recited the pledge of allegiance to the flag.

Distinguished Guests.

There being no objection, the following guests were introduced:

The Chair (Mr. Collins) introduced, in the rear of the Chamber, Adrian Bosco, a student at Boston Green Academy. Adrian was visiting the State House in recognition of having received the Christian A. Herter Memorial Scholarship for his perseverance in furthering his education. The Senate applauded his accomplishments, he was presented with a Senate Citation on the Rostrum, and he withdrew from the Chamber.

The yeas and nays having been completed at fourteen minutes before twelve o'clock noon, the bill was passed to be engrossed.

PAPER FROM THE HOUSE.

The House Bill making appropriations for the fiscal year 2026 for the maintenance of the departments, boards, commissions, institutions, and certain activities of the commonwealth, for interest, sinking fund, and serial bond requirements, and for certain permanent improvements (House, No. 4001),-- came from the House with the endorsement that the House had NON-concurred in the Senate amendment striking out all after the enacting clause and inserting in place thereof the text contained in Senate document numbered 2525, and had asked for a committee of conference on the disagreeing votes of the two branches; and that Representatives Michlewitz of Boston, Ferrante of Gloucester and Smola of Warren had been appointed the committee on the part of the House.

General appropriations bill.

On motion of Mr. Rodrigues, the Senate insisted on its amendment and concurred in the appointment of a committee of conference; and Senators Rodrigues, Comerford and O'Connor were appointed on the part of the Senate.

The bill was returned to the House endorsed accordingly.

Resolutions.

The following resolutions (having been filed with the Clerk) were severally considered forthwith and adopted, as follows:-

Senate Rule 36 was suspended, on motion of Mr. Tarr, and the report was considered forthwith. Joint Rule 12 was suspended; and the petition (accompanied by bill) was referred to the committee on Public Health.

PAPERS FROM THE HOUSE.

A petition (accompanied by bill, Senate, No. 2522) of Cindy F. Friedman, Andrea Joy Campbell, Attorney General, Joanne M. Comerford, Julian Cyr and other members of the General Court for legislation to strengthen health care protections in the Commonwealth,-came from the House with endorsement that the House concurred in the suspension of Joint Rule 12; and had NON-concurred in the reference to the committee on Health Care Financing. The petition bore the further endorsement that the matter had been referred to the committee on the Judiciary.

On motion of Mr. Tarr, the Senate receded from its reference to the committee on Health Care Financing and concurred in the reference to the committee on the Judiciary.

Emergency Preamble Adopted; Engrossed Bill Enacted.

An engrossed Bill making appropriations for the fiscal year 2025 to provide for

Supplemental appropriations.

supplementing certain existing appropriations and for certain other activities and projects (see Senate, No. 2521), having been certified by the Senate Clerk to be rightly and truly prepared for final passage and containing an emergency preamble,-- was laid before the Senate; and, a separate vote being taken in accordance with the requirements of Article LXVII of the Amendments to the Constitution, the preamble was adopted, in concurrence, by a vote of 2 to 0.

The bill was signed by the Acting President, (Mr. Collins) and sent to the House for enactment.

Subsequently, the bill, which originated in the Senate, came from the House with the endorsement that it had been enacted in that branch.

The Senate then passed the bill to be enacted; and it was signed by the Acting President (Mr. Collins) and laid before the Governor for her approbation.

Order Adopted.

On motion of Mr. Rodrigues,--

Ordered, That when the Senate adjourns today, it adjourn to meet again on Monday next at eleven o'clock A.M., and that the Clerk be directed to dispense with the printing of a calendar.

Adjournment in Memory of Lens Arthur Joseph.

The Senator from Suffolk, Ms. Miranda, moved that when the Senate adjourns today, it does so in memory of Lens Arthur Joseph.

I rise today with profound sorrow to ask that the Senate adjourn in memory of a beloved child whose life was tragically cut short far too soon — Lens Arthur Joseph, of Hyde Park, Massachusetts. Lens passed away on April 28, 2025, at just five years old, after a devastating accident involving the school bus that had brought him home from UP Academy in Dorchester, where he was completing his Kindergarten 2 year.

Born on August 8, 2019, in Arcahaie, Haiti, Lens came to the United States in August of 2023 and quickly became the heart and soul of the home he shared with his father, grandmother, uncle, aunt, and cousin in Hyde Park. Though young, Lens's presence was enormous. He had a wisdom and spark far beyond his years, and those who knew him fondly recall his bright mind, curious nature, and irresistible personality.

To his grandmother, he was "Lenso." To his uncle, he was "Maestro." And to his teachers and classmates, he was a beam of light — a joyful, intelligent, and kind boy who loved school, cared deeply for others, and often reminded his father with a confident grin, "You know I'm a smart guy!"

Lens had big dreams. At three years old, he proudly declared he wanted to be a pilot. By five, that dream shifted — he wanted to be a police officer, inspired by a sense of heroism and justice that belied his age. His teachers at UP Academy were preparing to honor him with a certificate for academic achievement — a tribute to his love for learning and his success, especially in mathematics. That certificate, presented posthumously at his funeral, is a lasting symbol of all he had already achieved, and all he had yet to do.

He loved cars, planes, and his favorite superhero, Spider-Man — fitting for a boy whose heart was as big as any comic book hero's. His casket, adorned in Spider-Man's red and blue, reminded everyone that even small heroes leave a mighty legacy.

In his home, Lens was a helping hand, a storyteller, a source of laughter and life. He'd asked his grandmother if she needed water, would talk endlessly with his uncle about what he learned in school, and stuck close to his cousin Miyah like a loyal shadow. His family described him as the "definition of life," a child whose presence could fill a room, and whose

absence now leaves a silence that is hard to bear.

Lens was the only son of his mother, Wilnese Moise, and the eldest child of his father, Esaie Joseph. He is mourned deeply by his parents, his two sisters — Wid-Kiarinah and Soumeika — his grandparents, aunts, uncles, cousins, and an extended family in both Haiti and the United States who cherished him dearly.

The loss of Lens has left a hole not only in his family, but in the entire Hyde Park and Boston community. In the words of his uncle, Ricardo Joseph, "It always takes a long time for nature to produce a person like Lens." Indeed, Mr. President, the world is richer for having known this sweet and special boy, and immeasurably poorer without him.

Therefore, Ms. President, I respectfully move that when the Senate adjourns today, it do so in memory of Lens Arthur Joseph — a brilliant light, a joyful spirit, and a beloved son, grandson, student, and friend. May his memory inspire us to hold our children a little closer, to fight for their safety, and to never forget the immense potential they carry in even their smallest steps.

May Lens rest in peace, and may his family be comforted in their time of unimaginable grief.

Accordingly, as a mark of respect to the memory of Lens Arthur Joseph, at sixteen minutes before one o'clock P.M., on motion of Mr. Rodrigues, the Senate adjourned to meet again on Monday next at eleven o'clock A.M.
