Thursday, January 24, 2008.

Pursuant to assignment, at eight minutes before seven o'clock, P.M., the two branches met in

JOINT SESSION

In the Chamber of the House of Representatives, for the purpose of receiving such communication as His Excellency Deval L. Patrick, Governor of the Commonwealth, may be pleased to make relative to the concerns of the Commonwealth; and were called to order by the Honorable Therese Murray, President of the Senate.

Order Adopted.

On motion of Mr. Panagiotakos,

Ordered, That a committee be appointed to consist of members of the Senate and House of Representatives to wait upon His Honor the Lieutenant-Governor, the Constitutional officers, members of the Executive Council, and other distinguished guests of the Governor and inform them that the two branches are now in Convention and request the honor of their presence.

Senators Candaras, Augustus, Brewer and Knapik were appointed on the part of the Senate; and Representatives Harkins of Needham, Torrisi of Andover, O'Flaherty of Chelsea, Wolf of Cambridge, Stanley of Waltham, Welch of West Springfield, Hall of Westford, Pedone of Worcester, Turkington of Falmouth, Lepper of Attleboro and Hill of Ipswich, were appointed on the part of the House.

Subsequently, Ms. Candaras, for the committee, reported that His Honor, Timothy P. Murray, the Lieutenant Governor, the Constitutional officers, the Executive Council and distinguished guests would immediately attend upon the convention.

Shortly thereafter, His Honor the Lieutenant-Governor, Timothy P. Murray, the Constitutional officers, members of the Executive Council, members of the Supreme Judicial Court and Adjutant General Joseph C. Carter entered the Chamber under the escort of the Sergeant-at-Arms.

Prayer.

The Speaker in the Chair, then introduced Reverend William E. Dickerson II, from the Greater Love Tabernacle in Dorchester, who delivered the following Invocation:

The President in the Chair, she then introduced Rabbi Jonah Pesner of Temple Israel in Boston, who gave the following Benediction:
