Department of Public Utilities Unified Carrier Registration Trust Fund

Between November 25, 2020 and October 12, 2021, the Department of Public Utilities collected \$1,558,411.40 in revenue and expended \$1,616,336.28 from the Unified Carrier Registration Trust Fund, starting with the FY2021 reported balance of \$1,663,257.24. The Unified Carrier Registration Trust Fund currently has a unexpended balance of \$1,605,332.36.

The spending from the Unified Carrier Registration Trust is to fund the payroll and administration costs, including vehicle, office supplies, travel, and reimbursements for eight full-time staff to administer the Federal Unified Carrier Registration program, as well as to fund enforcement activities in conjunction with the Massachusetts State Police.
