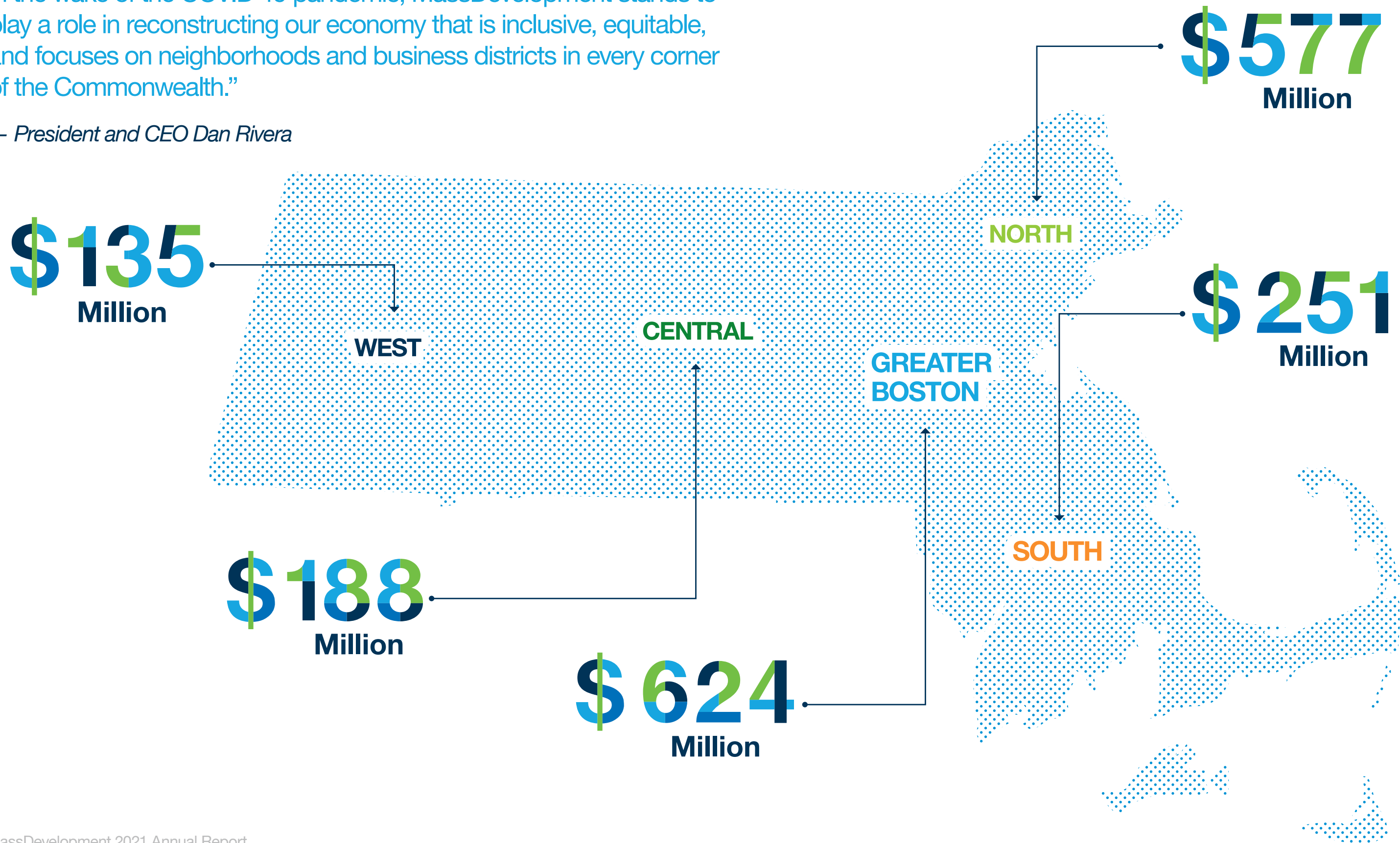

Building Brighter Futures in Roxbury

Children's Services of Roxbury (CSR) has spent nearly 50 years providing the state's most vulnerable families with housing and social services. This year, MassDevelopment guaranteed an **\$8.1 million loan** to help CSR purchase its 45,000-square-foot headquarters in **Roxbury**, significantly improving cash flow and increasing the organization's capacity to expand care to underserved children and families across the Commonwealth.

Investing in Higher Education

MassDevelopment has issued **tax-exempt bonds totaling \$179.6 million** to three institutions based in **Newton: Boston College, Lasell University, and William James College**. The schools, which enroll a combined total of approximately 17,740 students, will use bond proceeds to add new buildings to their campuses, renovate and improve existing facilities, and refinance previously issued debt.

Ensuring Vibrant Community Spaces

\$50,000 was awarded to **The Rose Fitzgerald Kennedy Greenway Conservancy** to enhance lighting infrastructure, make playground equipment updates, plant foliage, increase public art installations, and increase programming celebrating Asian and Asian-American culture in and around Auntie Kay and Uncle Frank Chin Park on the Greenway in **Boston's Chinatown neighborhood**. The grant is part of MassDevelopment's **Commonwealth Places** program, which invests in people and places to help reinvigorate the economy and aid recovery from COVID-19.

Students from Around the Region Have a New Place to Go

A **\$17 million tax-exempt bond** helped finance a new location for the **Collaborative for Regional Educational Services and Training (CREST)** in **Andover**, a nonprofit that provides educational, vocational, and therapeutic programs for children with developmental disabilities from 16 school districts throughout the region. The bond went towards buying and renovating a former office building so CREST could consolidate all its services and programs under one roof.

Nonprofits like CREST ensure students of all abilities have access to high-quality educational programming in a safe and welcoming environment, and helping CREST own a space for the important programs it runs for children with developmental disabilities is at the core of MassDevelopment's mission.

\$50,000 Grant for Capital Improvements

Improving Digital Access to Healthcare

The Lowell Community Health Center received a \$50,000 Community Health Center grant for capital improvements to fund a new multichannel communication system, enhancing efficiencies and improving patient outcomes. This was a crucial evolution of a health center service that has been offering high-quality, affordable healthcare to people of all ages since 1970, and will increase the health center’s ability to meet demand and evolve with the community’s needs.



\$250,500 from The Brownfields Redevelopment Fund

A New Mixed-Use project for Health, Housing, and Urban Beautification

MassDevelopment made two awards from the Brownfields Redevelopment Fund totaling \$250,500 to the North Shore Community Development Coalition, an organization focused on the reactivation of distressed neighborhoods. The projects will revitalize The Point neighborhood in Salem and include: The Lighthouses, a new 46-unit affordable housing project; and the nonprofit center, which will provide affordable senior housing, a new health center, and revitalized community space on the corner of Derby and Lafayette Streets. In 2021, the organization also received a \$10,000 Commonwealth Places grant to improve and drive foot traffic to four local storefronts.



SOUTH REGION

Making Business Better WITH US

At MassDevelopment, our work has helped local businesses grow, create new jobs, and provide unique benefits to their communities. This year, we've helped an emerging life sciences company launch new products and hire more employees; provided grants to build signage for small businesses; and helped an 8th-generation textiles manufacturer expand its operations.



A Surgical Devices Company Gets a Capital Infusion

MassDevelopment's **Emerging Technology Fund (ETF)** will help a **Stoughton** life sciences company create jobs and expand its product line. **Beeken Biomedical** is using a **\$1.5 million loan** to hire new employees and support company-wide growth as it launches innovative new product lines that help stop bleeding during surgeries.

MassDevelopment's ETF provides low-cost, long-term venture debt to early-stage and emerging tech companies, and will help Beeken Biomedical advance these life-saving technologies—a real win-win for Massachusetts. Our ability to support businesses with capital investment helps position the state as a desired location for more and more of the country's most innovative companies.

\$1 Million in Loan Financing

8th-Generation Textiles Company Pivots to PPE

\$1 Million in loan financing went to **Merrow Manufacturing**, a **Fall River** sewing and textiles company that pivoted to produce reusable and disposable Personal Protective Equipment during the COVID-19 pandemic. Merrow Manufacturing is now the largest producer of USA-sourced PPE, and MassDevelopment’s financing will support the first phase of a major expansion and buy equipment that will modernize the company’s manufacturing operations.



\$35,000 TDI Grant



Improving Small Business Signage in Attleboro

Ten small businesses throughout **downtown Attleboro** will benefit from a **\$35,000 Transformative Development Initiative (TDI) Local grant** providing design and production assistance for business signage. As communities across Massachusetts recover from COVID-19, better signage can help generate a timely boost of patronage and help increase local commercial activity.

\$70,000 in Site Readiness Funds

Supporting Redevelopment in Downtown Brockton

MassDevelopment awarded the **Brockton Redevelopment Authority \$70,000 in Site Readiness funds** to support redevelopment efforts for a downtown site on Frederick Douglass Avenue into a proposed 300-space public parking garage, workforce housing, and a vertical farm. Now in its fifth year, Site Readiness Program grants advance local projects and help revitalize underused parcels, spurring new economic growth.



WEST REGION

Supporting Manufacturing WITH US

At MassDevelopment, we understand just how important manufacturing is to the state's economy. Over the past year, our financing and resources have helped boost the West Region's manufacturing sector in innovative ways—turning a 16.5-acre power station into a new life sciences space, financing new production facilities, and helping build a new virtual reality lab for the engineering and life sciences communities.



Renowned Artist Supply Manufacturer Growing in Northampton

MassDevelopment helped **Chartpak**, a leading creative products company, expand into a third facility in Northampton, providing additional manufacturing space to accommodate increased sales and hire additional workforce. **Country Bank for Savings** purchased the **\$1.8 million tax-exempt bond**, which MassDevelopment enhanced with a **\$220,000 mortgage insurance guarantee**.

\$1.1 Million in Funding to Develop a 16.5-acre Tract

Former Power Transformer Facility Gets New Life

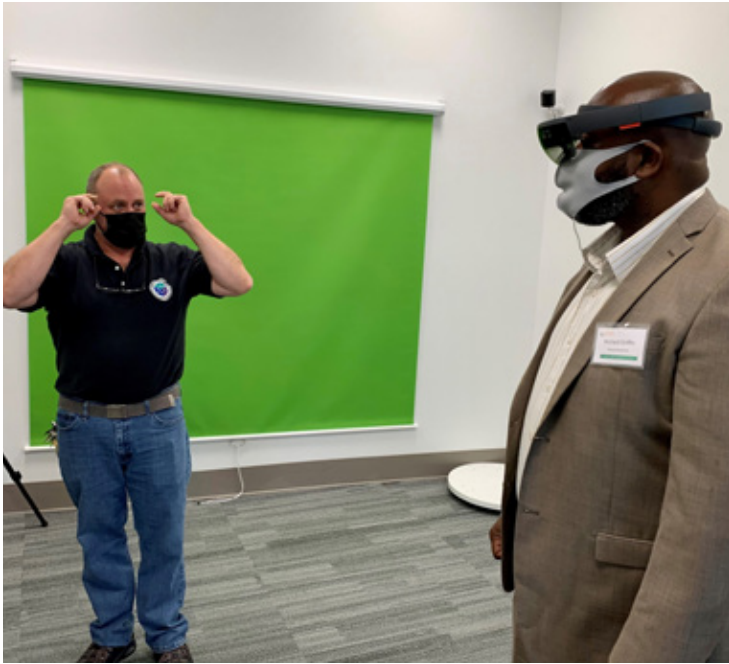
MassDevelopment helped provide over \$1.1 million in funding to develop a 16.5-acre tract within Pittsfield’s William Stanley Business Park. The site is the former home of a General Electric Power Transformer Facility, and funding from Massachusetts’ Site Readiness Program and Brownfields Redevelopment Fund will go towards decontamination and pre-construction costs. Construction is expected to begin in 2022 and the site aims to attract new opportunities in life sciences, manufacturing, or R&D.



\$14,435 from The Collaborative Workspace Program

Supporting the STEM Community in Berkshire County

The Berkshire Innovation Center (BIC) will use \$14,435 from the Collaborative Workspace Program to buy and install a VR/AR simulation lab. The BIC is a collaborative workspace that supports the life sciences and engineering community in Berkshire County, and its new technology will allow virtual meetings and conferences that will benefit its partners in industry and academia.

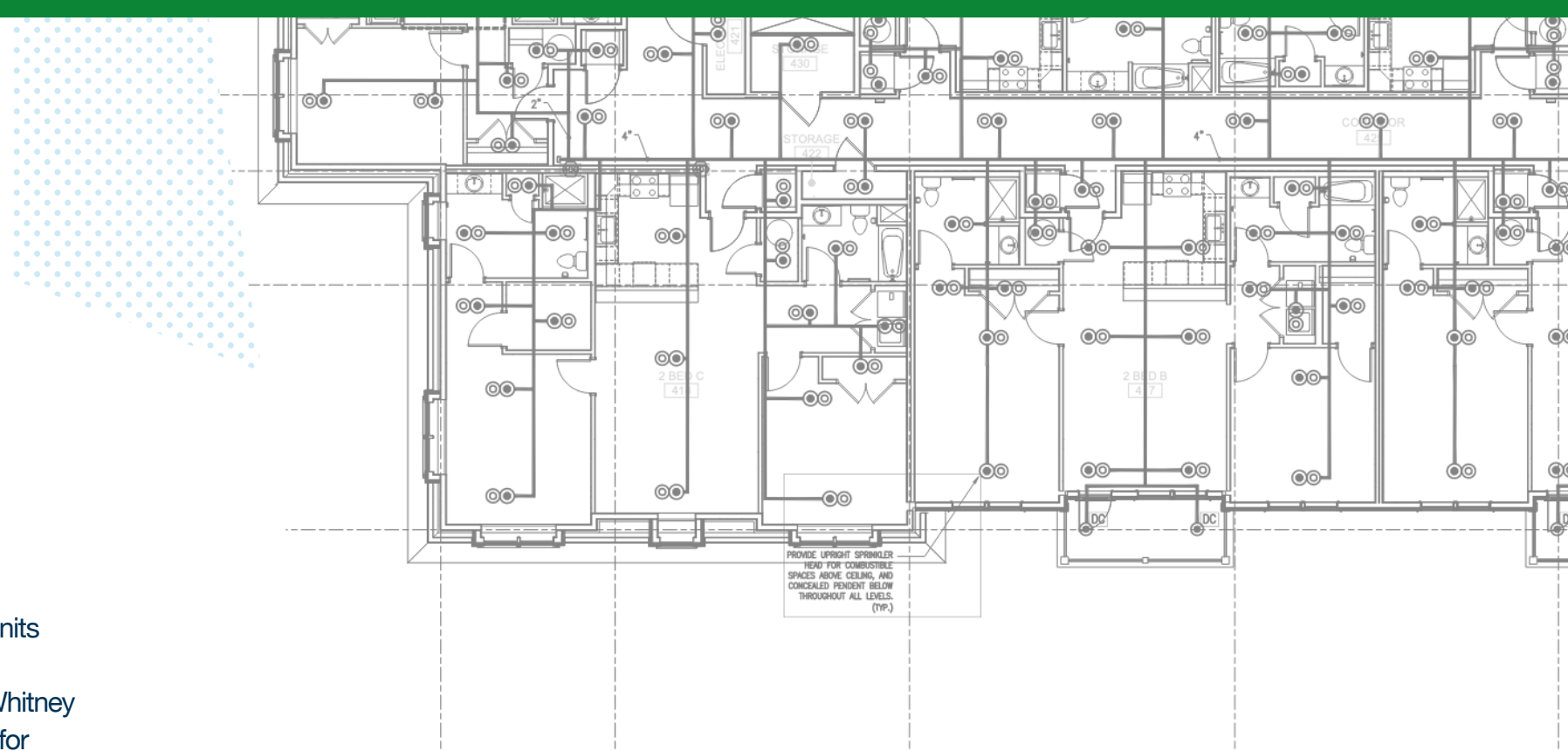
Building Smarter Housing WITH US

This year, we've partnered with some of the state's most forward-thinking banks to transform the housing market by creating thoughtful, equitable housing solutions. From building and renovating high-quality, mixed-income housing units to transforming damaged lots into premium market-rate units, our work is having a powerful positive impact in neighborhoods.



72 Units of Mixed-Income Housing in Sterling

MassDevelopment and Fidelity Bank have worked together on several housing projects including the construction of **Northgate Meadows** — a building consisting of 54 units of market-rate housing and 18 units of affordable rental housing on a 17.76-acre site conveniently located near Route 12 in the town of Sterling. MassDevelopment originally provided a **\$5 million participation** in a **\$12.9 million loan** to developer J. Whitney Development. This past fiscal year, MassDevelopment provided an additional **\$950,000 real estate loan** for associated project costs.

Vacant Former Boarding House Becomes 21 Market-Rate Apartments

MassDevelopment partnered with Clinton Savings Bank to provide \$2.5 million in loan financing to Summer Street Apartments, LLC, an affiliate of Cougar Capital Management, which will use the proceeds to convert a vacant former rooming house into 21 market-rate rental housing units in downtown Leominster. Originally constructed in 1840, the building played an important role in Leominster's early industrial history by housing workers from several area factories.

\$1.33 Million in Loan Financing

Seven New Rental Townhomes in Fitchburg

MassDevelopment teamed up with Main Street Bank to provide \$1.33 million in loan financing to construct seven new units of market-rate rental housing in downtown Fitchburg. The site had been sitting undeveloped for almost two decades after a fire in 2001. The developer, Nicholas Pelletier, is a local real estate professional and existing customer of Main Street Bank.
