Crime in Middlesex County is substantially down from pre-pandemic levels. For example, in calendar year 2019, there were 21,405 cases arraigned in District Court, 434 cases arraigned in Superior Court, and 416 cases arraigned in Juvenile Court, as well as 11 youthful offender cases arraigned, for a total of 22,266 arraigned cases. By contrast, in calendar year 2021, there were there were 15,193 cases arraigned in District Court, 409 cases arraigned in Superior Court, 265 cases arraigned in Juvenile Court, as well as 6 youthful offender cases arraigned, for a total of 15,873 arraigned cases. This reflects a 28.71 percent decrease in crime.

Most cases involve multiple charges and many cases from prior years remain unresolved but actively managed as a result of the COVID pandemic. The 15,873 cases arraigned in 2021 involved 39,252 charges. The breakdown of those charges is reflected in the chart below.
