Dear Superintendent Neville:

The Massachusetts Department of Public Health, Community Sanitation Program (CSP) has received your Plan of Correction in response to my inspection on October 13, 2022. After review, the CSP finds the plan appropriately addresses all of the violations noted in the report with the following exceptions:

1. The CSP appreciates the information provided regarding the shower cleaning schedules, however we cannot accept a plan of correction without an estimated date of completion. In instances where you state, "*Showers should be cleaned daily*", please provide a corrective action and the estimated date of completion;
2. Where it is indicated, "*Flynn Pest on site every 2 weeks continuing to combat any pest control issues*", please provide a corrective action and the estimated date of completion. Additionally, please confirm that the area noted with rodent droppings has been adequately cleaned and sanitized; and
3. In regards to the issue of overcrowding, the CSP appreciates the limitations of correctional facilities and the need to accommodate the ever-increasing population; however we remain concerned with the overcrowded conditions.
