Dear Chairs Rodrigues, Michlewitz, Friedman, Lawn, Velis, and Madaro,

As required by Section 13D1/2 of Chapter 118E of the General Laws, the Executive Office of Health and Human Services provides below a comparative analysis of the Community Behavioral Health Center (CBHC) rates as of December 2023. The following data reflects rates from all MassHealth Managed Care Entities (MCEs), including Managed Care Organizations, Accountable Care Partnership Plans, the behavioral health vendor, One Care, and Senior Care Options (SCO) plans, in comparison to the MassHealth (MH) Fee for Service (FFS) rate.

Table 1 depicts the CBHC rates by service code and description for MassHealth FFS in comparison to the MCE rates. All other payor rates, with the exception of Adult Mobile Crisis Intervention provided at an ED (S9485-HB), align with the rates set in MassHealth FFS and 101 CMR 305.00. The rate for S9485-HB ranges from a minimum of \$632.08 and a maximum of \$695.29 with an average and median rate of \$663.69.
