For calendar year 2023, the DOC reports that 575 men were admitted to MASAC at Plymouth. Of this number, 421 men were admitted under "straight" Section 35 orders and 152 were under both Section 35 and bail orders in connection with criminal matters. Additionally, there were 2 admissions in which the individual had a pending criminal charge but no custody status. As of December 12, 2022, the Memorandum of Understanding between DOC and Hampden County regarding Stonybrook has been terminated, as Stonybrook's substance use disorder treatment program was approved by DPH pursuant to 103 CMR 164 on November 11, 2022.
