51As—2104—that is our best estimate based upon actual children served and the average number of cases with multiple filings.

51B—we cannot total these

Child Fatality Investigations—These are actual child death investigations and do not include those cases reviewed at our quarterly child fatality review team meeting.

Disabled Abuse—240 referrals were received in this timeframe from DPPC.

SAIN Interviews—338 total—We cannot differentiate between juvenile, district and superior court at this time.

UAD—4 interviews related to unattended deaths

Non-Charged Investigations—751—this includes the pending DPPC investigations, the non-SAIN interactions by our Forensic Interviewers as well as investigations amongst the ADAs

Search Warrant—81 estimated search warrants were reviewed amongst the ADAs in the timeframe in question

Support Services to Law Enforcement—encompasses the estimated telephone calls amongst the 7 ADAs relative to charging/investigations, SORB/Parole responses to document requests, the felony reporting by the Worcester

Recovery Center, after-hours on-call responses and trainings conducted by CAC staff.

Civil Rights Violations—we did not have any investigations that fit into this category.
