DIVISION OF ADMINISTRATIVE LAW APPEALS 2016 REPORT TO THE GENERAL COURT PURSUANT TO § 4H OF CHAPTER 7 OF THE GENERAL LAWS

The Division of Administrative Law Appeals ("DALA") made considerable progress in 2016 and we are proud to submit this report, pursuant to § 4H of Chapter 7 of the General Laws. It is our intention to provide an overview of DALA's operation and the modifications it made to its operation during 2016.

I. Executive Summary

DALA is made up of two units: the General Jurisdiction Unit ("GJU") and the Bureau of Special Education Appeals ("BSEA"). In 2016, the GJU continued to reduce its backlog. The GJU continued to review and modify its practices and procedures to improve the quality of the service it provides to the people of Massachusetts and its agencies.

In 2016, the BSEA continued its outstanding work for the children, parents and school districts of Massachusetts. The BSEA, a nationally recognized leader in dispute resolution in the area of special education, provides a broad range of dispute resolution services applicable to disputes concerning eligibility, evaluation, placement, individualized education programs (IEPs), special education services, and procedural protections for students with disabilities. In addition, the BSEA provided trainings state-wide for the consumers of its services.

II. OVERVIEW OF THE DIVISION AND ITS MISSION

DALA is an independent agency responsible for providing individuals and state agencies with fair and impartial hearings in the most efficient manner

possible. As stated above, it has two independent units, its General Jurisdiction Unit and the Bureau of Special Education Appeals.

A. General Jurisdiction Unit

The GJU reduced its backlog by 281 cases in 2016. Tab 1 contains a list of open GJU cases as of January 6, 2017. This summary shows that the GJU has 4,484 open cases — down from 4,612 cases on March 11, 2016. DALA's backlog is made up of Rate Setting Cases and Retirement Cases. 3,206 of DALA's open cases are Rate Setting Cases and 1,097 are Retirement Cases. In 2016, the inventory of Retirement Cases was reduced by 44 cases and the GJU reduced the inventory of Rate Setting Cases by 237.

DALA's mission is to provide the due process hearings that are the precondition of other agencies' final agency actions and, when provided for by statute, to hear *de novo* appeals of other agencies' decisions. General Jurisdiction cases come to DALA in two ways: (1) by legislation mandating that certain types of cases be heard at DALA; and (2) upon request of an agency, subject to the approval of the DALA Chief Administrative Magistrate and the Secretary of Administration and Finance (ANF). Currently, DALA conducts hearings for approximately 20 state agencies, including the Contributory Retirement Appeal Board, the Board of Registration in Medicine, the Department of Public Health, and the Fair Labor Division of the Office of the Attorney General.

DALA is improving the quality of the service it provides to its users. During the last year, the GJU unit implemented a pro se procedural assistance program to help pro se litigants respond to the pre-hearing orders issued by the agency. Last year GJU staff also started using a new case tracking system. This system allows for quicker reference to files and their contents. In addition, the GJU is working toward streamlining the pre-hearing process to more quickly identify cases that may be resolved without a full evidentiary hearing and provide full evidentiary hearings to cases that require them within one year of filing. The review of GJU's practices and procedures will continue and changes will be made as needed.

B. Bureau of Special Education Appeals

The BSEA is an independent unit within DALA. It is federally funded through a grant managed by the Department of Elementary and Secondary Education (DESE). The Bureau was transferred from the DESE to the Division of Administrative Law Appeals by Chapter 131 of the Acts of 2010 to ensure independence from any educational agency that could be a party to or interested in the proceedings before the Bureau. Pursuant to the transfer legislation, the Bureau and its caseload are managed independently of DALA's other operations.

The BSEA provides a broad range of dispute resolution services applicable to resolution of disputes with respect to eligibility, evaluation, placement, individualized education programs (IEPs), special education services, and procedural protections for students with disabilities. BSEA's dispute resolution services include mediations, hearings, advisory opinions and settlement

conferences. The Bureau also provides facilitators for IEP Team meetings.

Parties to these proceedings include parents, school districts, private schools, the DESE, and other state agencies. The BSEA further, through an ISA with the Department of Mental Health, conducts mediations and due process hearings with respect to early intervention.

In fiscal year 2016², the BSEA received 10,800 rejected IEPs (an increase of 520 over the year before), 1085 mediation requests, and conducted 778 mediations (an increase of 45 over last year). The mediation agreement rate in 2016 was 85.9%. Also, during fiscal year 2016, 568 hearing requests were received (an increase from the 492 requests received during the prior year). Full evidentiary hearings resulting in 23 written decisions were conducted (representing an increase of 5 decisions over the number issued during the previous year). In addition, at least, 48 substantive rulings were issued. Tab 2 contains a multi-year summary of the BSEA's annual statistics.

In addition to performing its dispute resolution function, during 2016, BSEA staff conducted multiple training programs for Special Education Parent Advisory Councils, parent advocacy groups, school district personnel, non-profit groups, Massachusetts Continuing Legal Education presentations and other interested groups around the Commonwealth. This commitment to increasing the visibility of BSEA's service will continue in the next year.

The Bureau has met all of its statutory and regulatory requirements for processing pending cases.

III. ANALYSIS OF GJU CASES RECEIVED IN 2016

As required by § 4H of Chapter 7 of the General Laws, we focus on the GJU cases received in 2016 and their disposition.

Tab 3 contains a report of the cases opened in 2016. The report identifies the case by name of parties and docket number. The type of case is described in the docket number. For example, "CR" is Contributory Retirement, "RM" is Registration in Medicine, and "RS" is Rate setting. The report lists the "Case Date," the date the case was filed, and its status.

Tab 4 contains a report of the cases closed in 2016. The cases are listed by "Case Date." The older cases are listed first. Also provided is the "Closed date".

IV. STATISTICS ON GJU HEARINGS HELD AND DECISIONS ISSUED

In 2016, GJU conducted 171 full evidentiary hearings and issued 960 orders/decisions. The difference between the number of full evidentiary hearings and the number of orders issued is the result of several factors. First, the GJU is aggressively managing its docket to ensure that those cases that require a full evidentiary hearing get them as quickly as possible, while those matters that can be decided on the papers are. Second, the GJU is now dealing with the Rate Setting cases and, because of their age, some of these cases are no longer live controversies. They are being disposed of as efficiently as possible using orders to show cause and dismissals.

The number of hearings and orders/decisions were down from 2015 for a few reasons. At the end of 2015, DALA lost the services of one full time

magistrate and, in April of 2016, stopped using contractors. In addition, DALA disposed of about 250 ERIP cases through the use of the summary decision process in 2015. The remaining ERIP cases involved questions of fact and, therefore, they required a full evidentiary hearing. Moreover, in 2016 magistrates spent time becoming familiar with the new case tracking system and other modifications to DALA's policies and procedures.

V. CONCLUSION

We appreciate the opportunity to tell you about what DALA accomplished in 2016. DALA's work provides a vital service to the Commonwealth and its citizens. Our magistrates, hearing officers, mediators and staff are proud of their work and we look forward to meeting the challenges addressed in this report. We are convinced that the independent "central panel" approach to review of state agency actions is the fairest, most efficient and cost effective one available.

We look forward to working with you to continue our service to the people of Massachusetts and its agencies.
