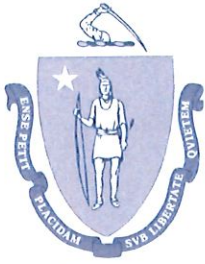
CIVIL PROCESS SERVICES

CIVIL PROCESS FEES PAID TO THE COMMONWEALTH OF MASSACHUSETTS

The Nantucket Sheriff's Office pays 25% of the fees from the revenues received serving court generated documents. These fees are paid to the Office of the State Treasurer on a quarterly or bi-yearly basis.
