Service Definitions							
<b>Home Visit -</b>	A Home Visit is a face to face meeting at the enrolled child's home or a setting outside of the EI program's primary site.						
<b>Center Visit -</b>	A Center Individual Visit is a face to face meeting at the EI program's site with the enrolled child and child's parents.						
<b>Child Group -</b>	A Child Focused Group is a face to face meeting at a community based site of a group of enrolled children.						
<b>EI Only Group -</b>	A EI Only Child Group is a developmental group where the only participants are children and families enrolled in EI.						
<b>Parent Group -</b>	A Parent Focused Group is a face to face meeting of a group of enrolled children's parents for the purpose of support and guidance.						
<b>Assessment -</b>	An Assessment consists of procedures by a multi-disciplinary team to determine a child's eligibility for service and assess strengths and needs.
