The Massachusetts Department of Public Health, Community Sanitation Program (CSP) has received your Plan of Correction in response to my inspection on February 26 and 27, 2020. After review, the CSP finds the plan appropriately addresses all of the violations noted in the report with the following exceptions:

- 1. Please provide a corrective action and date of completion for violations where you indicate the following:
 - a. Titan roofing contacted to assess and repair;
 - b. Suburban glass on site 3/12/20, quote pending repair/replacement;
 - c. Window assessed not a security risk to be submitted for capital funding;
 - d. Assessed not a security concern; and
 - e. Capital Project Window Replacement.
- 2. Please provide a corrective action and date of completion for the following Food Service violations:
 - a. Stainless trays stacked wet;
 - b. Gaskets damaged on Cooler # 6;
 - c. Pipes leaking next to kettles;
 - d. Missing backflow prevention device on 3-Compartment sink;
 - e. Exterior door not tight fitting at bottom in Recycling Area;
- 3. Please provide a corrective action and date of completion for the following violations:
 - a. Padding damaged on exercise equipment in the Gym;
 - b. Windows broken in the Back Office of the Gym; and
 - c. Gaskets damaged on refrigerator in Staff Break Room of South 1 Modular Unit.
