

## How To Submit Testimony Online on malegislature.gov


The **Committees** of the Massachusetts General Court welcomes your input and encourages anyone interested in providing testimony online to do so by visiting [malegislature.gov](http://malegislature.gov).

If you wish to provide your testimony to a committee that is accepting testimonies online, please follow the steps below:

1. Create a My Legislature account on our website by visiting [www.malegislature.gov](http://www.malegislature.gov).
2. Click on the person icon in the upper right corner of the page (icon shown below).




3. Click on the “Not Registered?” link at the bottom of the login window as shown below.

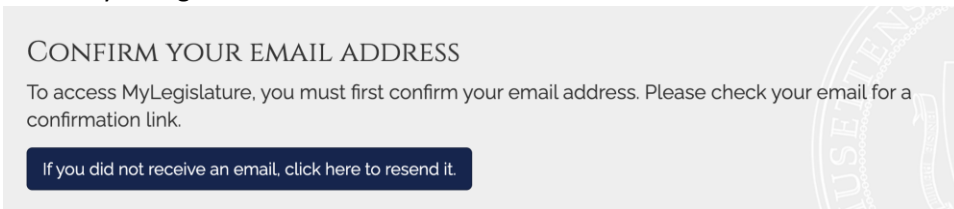
4. Enter your email address and create a password for your account. Be sure to check the box to verify you're human, and click the Register button.

- Once there, click the committee you’re interested in to view upcoming hearings, if available. Hearings will be listed in the upper right corner of the page, as shown in the example below.

- In the Hearing Details page, click the link as indicated in the example below to submit testimony online.

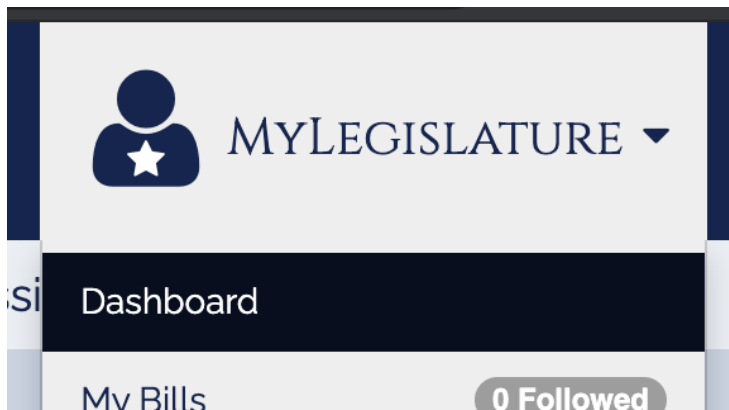
